#### **Project Description**

**Scope:** Proposed 6 ft. tall, 226 ft. long fence at Wright Park, a contributor to the Harold Bell Wright National Register Historic District. Fence will be a green vinyl coated chain link fence.

#### **Background:**

After more than a year of consultation with many stakeholders, it has been determined that a fence along the south end of the park is needed for security and safety reasons. The stakeholders we have had discussions with about this include our City of Tucson Parks and Recreation Department, the Tucson Police Department, the City of Tucson Historic Preservation Officer, Arizona State Historic Preservation Office, Harold Bell Wright neighborhood leadership, and officials from the St. Michael's School. Please see the bullet points below on the details of this project.

- The fence will run from the southwest corner of the park toward the southeast corner of the park but will leave a 15-foot-wide opening on the eastern end for pedestrian access from the neighborhood to the library and businesses that lie to the south of the park and neighborhood.
- St. Michael's School will be paying for the initial installation of the fence and Tucson Parks and Rec will maintain the fence after that.
- After the fence is installed, the Ward 2 office will be committing funds to have Parks and Rec plant a hedge in front of the fence that will be on regular irrigation. This hedge will consist of drought tolerant plants.
- Arizona State Historic Preservation Office finds no issue with the proposed fence being installed in the park and stated that a fence in the proposed location makes sense.

Please see our attached proposals.

Couple of notes regarding the fencing. We propose using <u>PrivacyLink</u> slatted fence. The specs are included. We have used PrivacyLink on many projects including some high schools, Raytheon and Pima County.

- \*Theses slats are factory inserted into the vinyl chain link. Traditional slats offer about 75% privacy, but PrivacyLink provides 98% privacy.
- \*Most vinyl chain link is 11 gauge wire, but this product is the much sturdier 9 gauge.
- \*The warranty on PrivacyLink is 15 years, while traditional slats provide a 7 year guarantee.
- \*Green/Green is available, but there are other color options available if you are interested.
- \*Factory inserted slats also look "cleaner" and prevent any cutting of the vinyl that might occur during manual slat installation

Also, please note that the primary fence bid includes the setting of the larger gate posts. If you choose to wait on the rolling gate, the posts will already be in place making the installation a simpler and cleaner process.


Additionally, when the rolling gate is installed, there will be three posts set due East of the driveway which will provide the gate with support (and keep from falling down) while opened.


